Membership Subscription

The annual subscription of £16.00 is per person and entitles the member to attend as many groups that they are able, subject to space being available, and that the required level of commitment to each group is possible. Some groups make a small charge to cover refreshments and necessary equipment. Purbeck U3A is a self help organisation and members are expected to help and support the running of groups they attend.

Publications

'Third Age Matters' is the magazine of the national U3A organisation and is issued in January, April, June, September and November and is an optional extra for which a charge of £2.90 is made to cover postage.

Purbeck U3A news items are routinely published on our website www.purbecku3a.org.uk. News items may include photographs of members which may also be posted on social media. A summary of such items may be collated and distributed at intervals to those members who do not have access to a computer. Requests for paper copies of news items should be notified to the Membership Secretary or Treasurer.

Data privacy

Your membership data as provided by you, is stored on U3A's external membership database entitled 'Beacon' and Purbeck U3A's membership data is held securely and separately from other districts' data. Back up copies of membership data and group records may be held on local computers.

Beacon systems may be used to contact you about your membership and emails will always include the name of the sender and usually originate from the address of noreply@u3abeacon.org.uk. Please add this address to your address book or white list.

Your email address will only be used by Purbeck U3A to contact you about your membership and other matters that we believe to be of interest to members. Your email address will be added to our Broadcasts distribution list and Broadcasts are sent intermittently but on average number less than 3 per month. Please add broadcasts@purbecku3a.org.uk to your address book or white list. You may unsubscribe from these Broadcasts at any time. Your email address will not be passed on or used outside U3A.

Gift Aid Declarations

You must pay an amount of Income Tax and /or Capital Gains Tax at least equal to the tax that the charity reclaims on your donations in the tax year (currently 25p for each £1 you give).

If, in the future, your circumstances change and you no longer pay tax on your income and / or Capital / Gains Tax equal to the tax that the charity reclaims, you may cancel your Declaration.
