Membership Subscription

The annual subscription of £16.00 is per person and entitles the member to attend as many groups that they are able, subject to space being available, and that the required level of commitment to each group is possible. Some groups make a nominal charge to cover refreshments and necessary equipment. Purbeck U3A is a self help organisation and members are expected to help and support the running of groups they attend.

Publications

'Third Age Matters*' is the magazine of the national U3A organisation and is issued in January, April, June, September and November and is an optional extra for which a charge of £2.40 is made to cover postage.

'The Bulletin' is the Purbeck U3A newsletter and is published at intervals throughout the year. It is routinely circulated by email and copies are available for download from our website. Paper copies are provided on request without charge for those members who do not have ready access to a computer or printer. Requests for paper newsletters should be notified to the Membership Secretary or Treasurer.

U3A Pocket Diaries* are £3.25 each including postage. Alternatively you may arrange to collect them from the Treasurer and pay only £2.50 each.

Data privacy

Your membership data is stored on U3A's national online database entitled 'Beacon' and Purbeck U3As membership data is held securely and separately from other district's data. Beacon systems may be used to contact you about your membership and emails will always show the name of the sender and reach you via the address of noreply@u3abeacon.org.uk. Please add this address to your address book or white list.

Your email address will be only be used by Purbeck U3A to contact you about your membership and other matters that we believe to be of interest to members. Your email address will be added to our Broadcasts distribution list with Broadcasts sent intermittently but on average number less than 3 per month. Please add broadcasts@purbecku3a.org.uk to your address book or white list. You may unsubscribe from these Broadcasts at any time. Your email address will not be passed on or used outside U3A.

Gift Aid Declarations

You must pay an amount of Income Tax and /or Capital Gains Tax at least equal to the tax that the charity reclaims on your donations in the tax year (currently 25p for each £1 you give).

If, in the future, your circumstances change and you no longer pay tax on your income and / or Capital / Gains Tax equal to the tax that the charity reclaims, you may cancel your Declaration.

You may cancel this Declaration at any time by notifying the charity.

If you pay tax at the higher rate you can claim further tax relief in your Self Assessment Return.

If you are unsure whether your donations qualify for Gift Aid tax relief, ask the charity or ask your local Tax Office for leaflet IR65.

Husbands and wives who are both tax payers must submit separate Gift Aid forms. If you require an additional form this can be obtained from the Treasurer or Membership Secretary.
